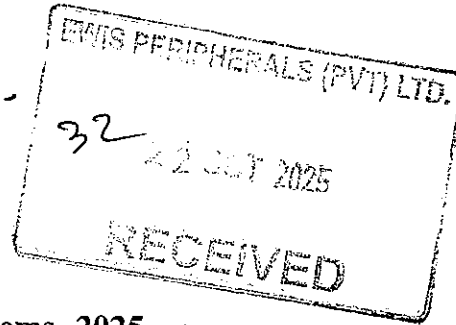


If there's any defect founds contract awarding will be refused.
