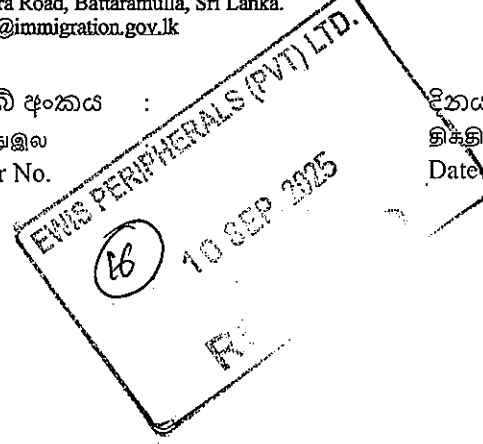

## Notification of Intention to Award the Contract

**Procurement of Supply, Delivery, Installation, Commissioning and Maintenance of 22 Nos. of Document Scanner Machines for the Department of Immigration and Emigration**

**This refers to the bid submitted by you for the above procurement.**

(2) The Department of Immigration and Emigration intends to award (recommended by Department Procurement Committee) the above contract to the substantially responsive lowest evaluated bidder, M/s Tech One Global Lanka Pvt. Ltd. , 435/16, Arangala Kottawa Rd. , Hokandara North Arangala for a total cost Rs. 2,596,000.00 (Without VAT).

(3) If you have any representations against the determination of DPC, you may request a debriefing from the Department as per the sub section 8.4 of the Government Procurement Guidelines 2024.

(4) If you would not be satisfied with the debriefing, you may appeal to the Department Appeal Board as per sub section 8.5 of the Government Procurement Guidelines 2024 on or before 19.09.2025. Address to submit appeal: **Chairman, Procurement Appeal Board, Department of Immigration and Emigration, Suhurupaya, Battaramulla.** All such bidders are requested to deposit a non-refundable fee of Rupees ten thousand (Rs.10,000/-) at the office of the Procurement Division at the Department of Immigration & Emigration and obtain a receipt. However, deposits will not be accepted without a written representation against the recommendation of the intended contract award. The Appeal will be considered only upon proof of such deposits.

(5) All appeals should be sent by registered post or handed over at the above mentioned address and an acknowledgement should be obtained.
