For Supplies:

If Lexmark should decrease the standard distributor prices on the products listed above, the rebate will be adjusted accordingly.

Condition precedent

The specific terms and conditions under this Quotation Letter are subject to the condition precedent that within 60 (sixty) days of the date of this Quotation Letter and the specified authorized distributor shall have received your initial order.

Miscellaneous

The terms and conditions of this Quotation Letter are granted by Lexmark to you. The Project Prices/Rebates are granted by Lexmark to the 1st tier purchaser exclusively for the Products. Project Prices/Rebates and Project-specific terms and conditions shall be valid only for the Project defined in Product Portfolio section and for internal use only.

Sale of the Products to a purchaser other than the end customer defined in this letter and a breach of any other terms and conditions of this Quotation Letter shall be considered misuse.

Lexmark reserves the right to change or modify Product specifications, discontinue Products, or to announce new or replacement Products at any time at its sole discretion, and without that any liability of Lexmark towards you arises out of this change or modification. In this case Lexmark will propose to you another Product with equivalent or better specifications than the prior Product.

Credit Requests
