Prices/Rebates and Project-specific terms and conditions shall be valid only for the Project defined in Product Portfolio section and for internal use only.

Sale of the Products to a purchaser other than the end customer defined in this letter and a breach of any other terms and conditions of this Quotation Letter shall be considered misuse.

Lexmark reserves the right to change or modify Product specifications, discontinue Products, or to announce new or replacement Products at any time at its sole discretion, and without that any liability of Lexmark towards you arises out of this change or modification. In this case Lexmark will propose to you another Product with equivalent or better specifications than the prior Product.

Credit Requests

For Hardware:
